This Resolution duly made and adopted this 12th day of August, 2003, by the Hardin County Fiscal Court, County of Hardin, Commonwealth of Kentucky.

WHEREAS, the Hardin County Fiscal Court duly enacted and adopted Ordinance No. 163, Series 2001, known as the Universal Solid Waste Collection and Disposal Ordinance on February 12, 2001;

WHEREAS, certain occupants subject to the provisions of the Universal Solid Waste Collection and Disposal Ordinance have failed and continue to refuse to pay the service fees established by said Ordinance.

NOW, THEREFORE, BE IT RESOLVED that the Hardin County Judge/Executive and the Hardin County Attorney are hereby authorized and directed to initiate civil action on behalf of Hardin County to collect the following delinquent accounts:


