

RESOLUTION NO. 2009-087

RESOLUTION OF OFFICIAL INTENT OF THE FISCAL COURT OF THE COUNTY OF HARDIN, KENTUCKY, TO REFINANCE THE 2005 SOLID WASTE BOND ISSUE TO HELP WITH CASH FLOW AND AUTHORIZATION OF THE FILING OF A PETITION WITH THE STATE LOCAL DEBT OFFICER

WHEREAS, in order for the County of Hardin, Kentucky to refinance the outstanding County of Hardin, Kentucky General Obligation Bonds (Hardin County Solid Waste Project), Series 2005 ("Series 2005 Bonds") for the Hardin County Contained Landfill prior to the authorization, sale and delivery of the proposed County of Hardin, Kentucky General Obligation Refunding Bonds (Hardin County Solid Waste Project), Series 2009, in the approximate amount of \$1,420,000 ("Bonds") to refinance the Series 2005 Bonds, it is a requirement of the income tax regulations of the Internal Revenue Service that the Fiscal Court express their official intent that the proceeds of such Bonds will be used, in whole or in part, to refund the Series 2005 Bonds prior to the issuance of the proposed revenue bonds; and


WHEREAS, it is the express intent of the County to authorize, sell and deliver a proposed issue of its Bonds in the approximate amount of \$1,420,000.00 to refinance the Series 2005 Bonds; and


WHEREAS, it is necessary and appropriate for this Fiscal Court to authorize the petitioning to the State Local Debt Officer to approve the County's issuance of the Bonds

NOW THEREFORE, BE IT RESOLVED BY FOLLOWS:

1. The Fiscal Court of the County of Hardin, Kentucky does herewith express its intent to cause to have issued the Bonds in the approximate amount of \$1,420,000.00 to refinance all or a portion of the refunding of the Series 2005 Bonds and that all expenditures made for said refunding prior to the sale of such Bonds shall be reimbursed out of the proceeds of such sale.
2. The fund or account to be reimbursed is the Solid Waste Fund or any other fund of the County of Hardin.
3. That the County authorizes the County Judge/Executive to execute a Petition to the State Local Debt Officer on behalf of the County requesting the State Local Debt Officer to approve the issuance of the Bonds by the County.
4. This Resolution shall take effect from and after its passage and approval.


