

**HARDIN COUNTY FISCAL COURT  
RESOLUTION NO. 2012-177**

*To remove a certain section of Hayden School  
Road from the County Maintenance System*

**WHEREAS**, Resolution No. 2012-034, dated 27 March 2012, approved an interlocal agreement between the County of Hardin and the City of Elizabethtown and an agreement with Silver Gate, LLC (herein referred to as Agreement) for the purpose of providing for the improvements and on-going maintenance of Hayden School Road; and

**WHEREAS**, said Agreement pertains to the section of Hayden School Road between St. John Road and the corporate limits of Elizabethtown, said limits being some 1,320 feet from St. John Road, as measured along the roadway, consisting of approximately 1.4 acres of right-of-way; and

**WHEREAS**, the drainage and paving improvements to Hayden School Road, according to the plans referenced in said Agreement have been completed; and

**WHEREAS**, consent to the City of Elizabethtown for annexation of said Hayden School Road right-of-way was granted by Harry Berry, Judge/Executive for Hardin County government on 1 October 2012; and

**WHEREAS**, the City of Elizabethtown completed the annexation of said Hayden School right-of-way per resolution of the City Council on December 3, 2012;


**BE IT RESOLVED**, upon recommendation of Judge/Executive Harry L. Berry, to authorize the Judge/Executive to take the necessary actions to remove the section of Hayden School Road between St. John Road and the corporate limits of Elizabethtown, said limits as being some 1,320 feet from St. John Road as measured along the roadway, from County maintenance.
