

**COMMONWEALTH OF KENTUCKY
HARDIN COUNTY FISCAL COURT**

RESOLUTION NO. 2012-185

The Hardin County Fiscal Court, Commonwealth of Kentucky, hereby adopts the following Resolution on this the 21st day of December, 2012.

WHEREAS, Hardin County Fiscal Court adopted the KENTUCKY BUILDING CODE to provide for safe construction and housing for its residents; and

WHEREAS, Hardin County Fiscal Court appointed the Hardin County Planning and Development Commission in a RESOLUTION adopted June 1, 1989, to administer the KENTUCKY BUILDING CODE as prescribed in the KENTUCKY REVISED STATUTES in Chapter 198 B; and

WHEREAS, the Hardin County Planning and Development Commission is authorized and is held responsible "...to receive, hold, and spend funds which it legally receives from any and every source..." as prescribed by the KENTUCKY REVISED STATUTES in Chapter 100; and

WHEREAS, the AGREEMENT to administer the KENTUCKY BUILDING CODE adopted by Hardin County Fiscal Court on July 6, 1981 states that "...the Commission shall be entitled to charge fees for services as set by the County..."; and

PURSUANT to the authority granted to the Hardin County Planning and Development Commission by Hardin County Fiscal Court, and the KENTUCKY REVISED STATUTES,

NOW, THEREFORE, BE IT RESOLVED, by the Hardin County Fiscal Court, Commonwealth of Kentucky, that the attached revised application fee schedule shall be


implemented for electrical inspections performed on all projects and proposals occurring within the jurisdiction of the Commission, said application fee shall supersede all previous established application fees, with an effective date of January 1, 2012.
