BE IT RESOLVED, upon the recommendation of Judge/Executive Harry L. Berry, with the concurrence of the Public Works Committee to revise Resolution No. 2008-081 relinquishing ownership of Gaither Station Access Road to the Commonwealth of Kentucky;

BE IT FURTHER RESOLVED, the county continues to agree to accept the maintenance responsibility of this roadway section, including shoulders and guardrail into the County Road System. Said roadway section being further described as follows:

Maintenance Only of Gaither Station Access Road at Rt. Station 102+08.80 from the edge of pavement of newly constructed KY 3005 (Ring Road) to Gaither Station Road, a total distance of approximately 690 feet (Sheets R5,R7) and;

BE IT FURTHER RESOLVED, the Judge/Executive is authorized and directed to sign said resolution, as set forth, on behalf of the HARDIN COUNTY FISCAL COURT, and the County Clerk of HARDIN COUNTY is hereby authorized and directed to certify thereto.
