This Resolution duly made and adopted on this 10th day of June, 2014, by the Hardin County Fiscal Court, Commonwealth of Kentucky.



This Resolution adopted by the Hardin County Fiscal Court on the date hereinabove mentioned.





I am requesting the Court grant a transfer of this contract to my son Casey Jenkins. The contract dates are July 1, 2014, through June 30, 2015.


