RESOLUTION NO. 2015-152**


**BE IT RESOLVED**, upon recommendation of Judge/Executive Harry L. Berry, to approve the following changes within the EMS Department:

1. The change of status of Wesley Thornhill, from part time EMT, Grade 4, Step EOI, to full time EMT, 56 hour work week, Grade 4, Step EOI, at \$10.88 per hour, with uniform allowance of \$400 per fiscal year, and with scheduled overtime, effective 20 September 2015.
2. The change of status of Megan Dobrai, from full time EMT, 40 hour work week, Grade 8, Step EOI, to full time EMT, 56 hour work week, Grade 4, Step EOI, at \$10.88 per hour, with uniform allowance of \$400 per fiscal year, and with scheduled overtime, effective 20 September 2015.

6. The change of status of Billy Keith, from part time EMT, Grade 8, Step EL, to full time EMT, 40 hour work week, Grade 8, Step EL, at \$12.59 per hour, with uniform allowance of \$400 per fiscal year, and without scheduled overtime, effective 20 September 2015.
7. The resignation of James L. Riggs, Paramedic, effective 7 September 2015.
8. The change of status of Thomas C. Miller, from full time EMT, 56 hour work week, Grade 4, Step 7, to part time EMT, Grade 4, Step 7, at \$12.38 per hour, with uniform allowance of \$200 per fiscal year, and without scheduled overtime, effective 5 September 2015.


