RESOLUTION NO. 2017-043**


BE IT RESOLVED, upon recommendation of Judge/Executive Harry L. Berry, to approve the following changes within the EMS Department:

5. The change of status of Jennifer Kant, part-time EMT, Grade 4, Step EOI, to full-time EMT, 56 hour work week, Grade 4, Step EOI, at \$10.98 per hour, with \$400.00 uniform allowance per fiscal year, and with scheduled overtime, effective 2 April 2017.
6. The change of status of Wesley Thornhill, EMT, 56 hour work week, Grade 4, Step 1, to part-time EMT, Grade 4, Step 1, at \$11.20 per hour, with \$200.00 uniform allowance per fiscal year, effective 16 April 2017.
