## HARDIN COUNTY FISCAL COURT

REGULAR MEETING APRIL 23, 2013

Hardin County Judge/Executive Harry L. Berry called the Hardin County Fiscal Court Meeting to order and requested a roll call vote. Voting: Goodman yes, Williams yes, Clem yes, Wiseman yes, Thompson yes, Morgan yes, King yes, Judge Berry yes, Easter yes.

The invocation was given by Squire Easter.

Squire Wiseman led the court in the pledge of allegiance.

Informational Items:

Bo O'Brien, Elizabethtown Tennis Commission, came before the court to explain all of the Tennis Activities taking place and announced that May was Tennis Month.

Bob Hack, Relay for Life, shared with the court the amount of the money collected to combat cancer and how they helped cancer patients. He invited everyone out May 10<sup>th</sup> at 6:00 p.m. at Central Hardin High School.

The Hardin County Extension Service 2013/2014 budget was presented by Steve Wooden, Doug Shepherd and Angela Jenkins were also present.

Department/Office Reports:

Dr. Lee, Hardin County Coroner, presented the Hardin County Coroner's report.

Deputy Sheriff Donna Cross presented the Budget report.

Kenny Tabb, Hardin County Clerk, presented the Hardin County Clerk's March report.

Written reports were submitted by EMS, E-911 Dispatch Center, Detention Center and Planning and Development.

**Public Comments:** 

Judith French reminded the court that the recent decision was not in the taxpayers' best interest for lack of notification. There are places downtown that the county government could utilize.

Jack Kunnecke, Cherrywood Drive, feels that the decision was rushed. The reports do not add up on page 5. The County Attorney's Office was not taken out. He said that too much space was being allocated and too many conference rooms. He recommended that the County Clerk, PVA and County Attorney be left downtown, would require 30,000 square feet building out of town. Downtown will not revive with vacant buildings.

Elsie Hall stated 73% of people polled in the *News Enterprise* are opposed to moving out of downtown. She wants to know exactly how much the building will cost. The decision was done in haste. The meeting time was changed to 2:00 p.m. instead of 3:30 p.m.

Charles Lanz, 124 French Street, is opposed to moving county government out of downtown. He quoted the Judge as saying the people put him in and the people could take him out. He remembered all of the stores downtown. He is disappointed that the court would leave downtown after all of these years. He wants the court to rethink this. He will fight this as much as he can.

The Judge stated he does not remember the conversation with Mr. Lanz.

Bobby Alexander commended the court for their move and feels it is in the best interest of most people of the county. He is happy with the way the court is running and managing the county. He encouraged them to keep up the good work.

Judge Berry presented the proposed 2013/2014 County Budget.
