ORDINANCE NO. 298, SERIES 2014

**AN ORDINANCE RELATING TO THE DESIGNATION
OF “NO PARKING” AREAS IN THE UNINCORPORATED
AREAS OF HARDIN COUNTY, KENTUCKY**

BE IT ORDAINED BY THE FISCAL COURT OF COUNTY OF
HARDIN, COMMONWEALTH OF KENTUCKY, AS FOLLOWS:

WHEREAS, KRS 189.390 (5)(C) provides that a Fiscal Court of any county may, upon the basis of an engineering and traffic investigation and study, determine it is unsafe to park motor vehicles on or along any highway within the unincorporated area of such county and may prohibit such parking; and

WHEREAS, the Hardin County Fiscal Court has received an engineering and traffic investigation study completed by Ronnie Goodman, Hardin County Road Supervisor, dated May 6, 2014, indicating that the following highways located in unincorporated Hardin County known as WILLIAMSBURG DRIVE, SOUTH AIRVIEW DRIVE, SECRETARIAT ROAD, NORTH RIDGE ROAD, SOUTH RIDGE ROAD, OAK STREET, VANGOSEN COURT, GLENWOOD DRIVE, and TOM DUVALL ROAD are unsafe to park motor vehicles on or along such street. A photocopy of said engineering and traffic investigation is attached hereto and made a part hereof.

NOW, THEREFORE, IT IS HEREBY ORDAINED, by the Hardin County Fiscal Court, Commonwealth of Kentucky, as follows:

1. Pursuant to KRS 189.390 (5)(C) and the engineering and traffic investigations study filed herewith, there is hereby established a “No Parking” area on any portion of the sidewalks or hard surface pavement of WILLIAMSBURG DRIVE, SOUTH AIRVIEW DRIVE, SECRETARIAT ROAD, NORTH RIDGE ROAD, SOUTH RIDGE ROAD, OAK STREET, VANGOSEN COURT, GLENWOOD DRIVE, and TOM DUVALL ROAD in Hardin County, Kentucky, for the entire length of said street
2. The Hardin County Road Department is hereby authorized to erect sufficient signs and notices of the established “No Parking” designation on WILLIAMSBURG DRIVE, SOUTH AIRVIEW DRIVE, SECRETARIAT ROAD, NORTH RIDGE ROAD, SOUTH RIDGE ROAD, OAK STREET,

VANGOSEN COURT, GLENWOOD DRIVE, and TOM DUVALL ROAD. As provided in KRS 189.990 (1) any person who violates this order shall be fined not less than \$11.00 nor more than \$30.00 and neither court costs nor fees shall be taxed against any persons violating this order.

3. The effective date of this Ordinance shall be July 1, 2014. The Hardin County Judge/Executive shall cause to be advertised in any local newspaper at least once public notice of this order. The Clerk of this court shall cause a photocopy of this order to be forwarded to Kentucky State Police, Post No. 4, Elizabethtown, Kentucky and the Hardin County Sheriff's Office.

SECTION I

If any part of this Ordinance shall be held invalid, such part shall be deemed severable and the invalidity thereof shall not affect the remaining parts of this Ordinance.

SECTION II

Given First Reading on the 27th day of May, 2014.


Given the Second Reading on the 10th day of June, 2014.

Adopted by the Fiscal Court of Hardin County, Kentucky, on the 10th day of June, 2014.






