REGULAR MEETING FEBRUARY 14, 2012

Hardin County Judge/Executive Harry L. Berry called the Hardin County Fiscal Court Meeting to order and requested a roll call vote. Voting: Clem yes, Wiseman yes, Thompson yes, Morgan yes, King yes, Judge Berry yes, Easter yes, Goodman yes, Williams yes.

The invocation was given by Squire Goodman.

Squire Morgan led the court in the pledge of allegiance.

Judge Berry read and presented a proclamation to Larry Vance, Hardin County Detention Center Chaplain Emeritus, for 35 years of service to Hardin County and Commonwealth of Kentucky.

Brad Richardson, Executive/Director, presented the Hardin County Chamber of Commerce Update.
