

**HARDIN COUNTY FISCAL COURT
RESOLUTION NO. 2022-34**


WHEREAS, an internal audit was performed on the Step in Grade pay system which identified the following movements within the EMS Department requiring corrections,

BE IT RESOLVED, upon recommendation of Judge/Executive Harry L. Berry, to approve the following corrections:

1. The promotion of Chloe Bass from 56 hour EMT, Grade 5, Step 2, to 56 hour EMT-Advanced, Grade 7, Step 2, at \$14.04 hourly, with a uniform allowance of \$400 per fiscal year, retroactive 15 August 2021.
2. The promotion of Timothy Gillum from 56 hour EMT, Grade 5, Step 3, to 56 hour Paramedic, Grade 9, Step 3, at \$15.79 hourly, with a uniform allowance of 400 per fiscal year, retroactive 7 November 2021.
3. The change of status of Kevin Meiser, 56 hours EMT, Grade 5, Step 5, to part-time EMT, Grade 9, Step 5, at \$16.43 hourly, with a uniform allowance of \$200 per fiscal year, retroactive 15 August 2021.
4. The promotion of Kevin Meiser, part-time EMT, Grade 9, Step 5, to part-time Paramedic, Grade 13, Step 5, at \$19.97 hourly, retroactive 10 October 2021.
5. The change of status of Stephen Miller from 56 hour EMT, Grade 5, Step 4, to part-time EMT, Grade 9, Step 4, at \$16.11 hourly, with a uniform allowance of \$200 per fiscal year, retroactive 26 September 2021.
6. The promotion of Stephen Miller from part-time EMT, Grade 9, Step 4, to part-time Paramedic, Grade 13, Step 4, at \$19.58 hourly, with a uniform allowance of \$200 per fiscal year, retroactive 21 November 2021
7. The promotion of Robert Phillips from 56 hour EMT, Grade 5, Step 3, to 56 hour Paramedic, Grade 9, Step 3, at \$15.79 hourly, with a uniform allowance of \$400 per fiscal year, effective 7 November 2021.
8. The change of status of Brittany Rainwater, 56 hour EMT, Grade 5, Step 3, to part-time EMT, Grade 9, Step 3, at \$15.79 hourly, with a uniform allowance of \$200 per fiscal year, retroactive 24 October 2021.
9. The change of status of Brittany Rainwater from part-time EMT, Grade 9, Step 3, to 56 hour EMT, Grade 5, Step 3, at \$12.97 hourly, with a uniform allowance of \$400 per fiscal year, retroactive 2 January 2022.
10. The promotion of Timothy Gillum from 56 hour EMT, Grade 5, Step 3, to 56 hour Paramedic, Grade 9, Step 3, at \$15.79 hourly, with a uniform allowance of \$400 per fiscal year, retroactive 7 November 2021.
