


**HARDIN COUNTY FISCAL COURT  
RESOLUTION NO. 2022-029**

**BE IT RESOLVED**, upon recommendation of Judge/Executive Harry L. Berry, to approve the following changes within the EMS Department:

1. The hiring of Dustin Wade, 56 hour Paramedic, at Grade 9, Step 5, at \$17.25 hourly, with a uniform allowance of \$400 per fiscal year, retroactive 28 January 2022.
2. The hiring of Shawn Thomas, part-time EMT, at Grade 9, Step EOI, at \$15.62 hourly, with a uniform allowance of \$200 per fiscal year, effective 16 February 2022.

6. The hiring of Brian Reno, 56 hour EMT, at Grade 5, Step EOI, at \$12.84 hourly, with a uniform allowance of \$400 per fiscal year, effective <sup>16</sup>February 2022.
7. The hiring of Ariel Burden, part-time EMT, at Grade 9, Step EOI, at \$15.62 hourly, with a uniform allowance of \$200 per fiscal year, effective 25 February 2022.
8. The hiring of Ryan Clark, part-time EMT- Advanced, at Grade 11, Step EOI, at \$17.23 hourly, with a uniform allowance of \$200 per fiscal year, effective 23 February 2022.
9. The movement of Justin Yingling from Grade 9, Step EOI to Grade 9, Step 1, upon successful completion of his six-month introductory period, at \$15.18 hourly, retroactive 21 November 2021.
10. The movement of Justin Yingling from Grade 9, Step 1, at \$15.18 hourly, to Grade 9, Step 1, at \$15.93 hourly, retroactive 16 January 2022.


