Magistrates' Comments:

Squire Clem – I just want the community to remember Central Hardin High School. They lost a student this weekend. They're struggling with that news. He was a fine young man. Squire Ronnie Goodman- I would like to ask Sheriff John Ward if they passed Legislation to have security for every school?
