REGULAR MEETING September 28, 2021

Judge/Executive Harry L. Berry called the Hardin County Fiscal Court meeting to order and requested a roll call vote. Answeing: King yes, Judge Berry yes, Easter yes, Doug Goodman yes, Williams yes, Clem absent, Wiseman yes, Thompson absent, Ronnie Goodman yes.

The Invocation was given by Squire Easter.

Squire Williams led the court in the Pledge of Allegiance.

Public Hearing for Road Closing - Serene Oaks Subdivision

Conducted by Jenny Oldham, County Attorney (absent) Conducted by Don Jones, First Assistant County Attorney.

Presentation and Written Report – Adam King

First Assistant Don Jones - We are here to conduct the hearing on road closure pursuant KRS 178. There are a few items to put on record first before having Mr. King to testify before Fiscal Court. There has been a request made by B&B Homes LLC to discontinue an undeveloped future street 50 foot right-a-way north of Rebecca Ann Court at Rosenberger Lane, Elizabethtown Ky., in the Serene Oaks Subdivision Sect 2. The Public Hearing was initially scheduled for 3:30 p.m. today and notice of that date and time was made by placing three signs on the property September 10, 2021 and by first class mailing to all adjoining property owners also tendered on September 10, 2021 and by placing an ad in the News Enterprise dated September 19, 2021. No one has contacted the department of Planning and Development to express interest or opposition. The Planning staff will be present at 3:30 p.m. here at the Fiscal Court Hearing Room should someone wish to be heard on this matter. If that should occur then we would reopen the hearing to allow those individuals to speak. On September 14, 2021 Fiscal Court appointed viewers; Charlie Allen, Adam King and Dwight Morgan to make a written report to the court as to any inconvenience that would result from the discontinuance of the road and that report is included in your materials and the law requires the Planning Commission to review discontinuance of the road in accordance with the County's comprehensive plan and Adam King is going to speak to that.

Adam King was sworn in by First Assistant Don Jones.

Mr. King provided the background regarding the Road closing. Mr. King was asked to tender to the Clerk the exhibits, the views report and the road closing summary report. There was no one present to comment on the proposal by B&B Homes LLC to close the road north of Rebecca Ann Court at the Rosenberger Lane. Seeing no one the Public Hearing was closed.
