
BE IT FURTHER RESOLVED, to authorize the Judge/Executive to sign all documents relating to IGSA agreement and amendments.

MEMORANDUM FOR RECORD

SUBJECT: Amendment of Intergovernmental Support Agreement (IGSA) # IM-W9124D-20002-IGSA Expiration Date 10 March 2030 for U.S. Army Garrison Knox (USAG Knox) and Hardin County Government (Hardin).

1. Reference.
 - a. IMCOM IGSA Handbook, Support Agreement, dated May 2020.
 - b. OPORD 20-005, Installation Management Command (IMCOM) Intergovernmental Support Agreement (IGSA) Program (U)
2. Purpose. To modify the IGSA IM-W9124D-20002-IGSA Hardin Ground Maintenance between USAG Knox and Hardin County.
3. Action. The IGSA between USAG Knox and Hardin is amended to address the additional cost of mowing range areas that were not adequately identified in the original IGSA description of services, approximately 200 additional acres, at an additional cost of \$9346.04 per month. This memorandum acknowledges the error, and allocates the \$9346.04 additional monthly cost evenly between USAG Knox (\$4673.02) and Hardin County (\$4673.02). The amendment accounts for and resolves inaccuracies between the mowing maps and the acreage amounts listed in the IGSA and will expire on 1 April 2022.
