

<b>County Request and Agreement for Litter Abatement Program Grant Funding</b>			
<b>1. Grant Year</b>	2023		
<b>2. Federal ID Number</b>	61-6000756		
<b>3. County</b>	Hardin		
<b>4. TERMS AND CONDITIONS FOR GRANT FUNDING</b>			
<b>4(a).</b>	The grantee shall conduct three litter cleanups along public roads each year as required by KRS 224.43-345 and 401 KAR 49:080, Section 3(1) in accordance with 401 KAR 49:080 Section 1(5). A public road cleanup is defined as the "cleanup of litter along a number of public road miles equivalent to one-third (1/3) of the total public road miles in the solid waste management area, excluding total city street miles".		
<b>4(b).</b>	Unless the incorporated city received litter abatement grant funding, the grantee shall conduct litter cleanups along city streets two (2) times per year in accordance with 401 KAR 49:080 Section 1(5). A city street cleanup is defined as the "cleanup of litter along a number of city street miles equivalent to one-half (1/2) of a city's total street miles".		
<b>4(c).</b>	The amount of litter abatement program grant funding is determined in accordance with KRS 224.43-505 and the total number of applicants applying for the grant.		
<b>4(d).</b>	The litter abatement program grant funding shall be used for direct expenses, as defined in 401 KAR 49:080 Section 1(2), incurred during the calendar year which the grant is distributed, associated with litter abatement programs, for litter cleanup on public roads and city streets as provided in KRS 224.43-505, and to meet the requirements established in KRS 224.43-345.		
<b>4(e).</b>	By March 1, of the year following the grant distribution, the grantee shall submit a completed "Solid Waste Management Area Annual Report", DEP 6061, to the cabinet.		
<b>4(f).</b>	Litter abatement program grant funds not spent during the calendar year shall be submitted to the cabinet by April 15 <sup>th</sup> the year following grant distribution.		
<b>5. CERTIFICATION</b>			
The county hereby applies for grant funding for litter abatement program activities allowed pursuant to KRS 224.43-505, and agree to the above terms and conditions. I am aware that KRS 224.99-010(4) provides for penalties for submitting false information, including the possibility of fine and imprisonment for knowing violations.
