MEMORANDUM FOR RECORD

SUBJECT: Final Amendment – Renewal 4 of 4 of the Intergovernmental Support Agreement #IM-W9124D-18001-IGSA CST EMS between US Army Garrison, US Army Cadet Command, and Hardin County EMS.

1. Reference.

a. IGSA #IM-W9124D-18001-IGSA CST EMS between US Army Garrison, US Army Cadet Command and Hardin County EMS, 16 May 19.

b. 10 U.S.C. § 2679 – Installation-Support Services: Intergovernmental Support Agreements.

c. IMCOM IGSA Handbook.

2. Purpose. To renew the Intergovernmental Support Agreement (IGSA or Agreement) providing emergency medical service (EMS) support for the Cadet Summer Training (CST).

3. Renewal. The Parties hereby renew the CST EMS IGSA pursuant to the provisions entitled "Terms of Agreement" in the Agreement. Under this renewal, the United States shall only be obligated for an additional one year of performance. This is the third of four potential renewal option periods contemplated by the Agreement. This renewal will support the 2023 CST.

4. CST 23 IGSA Ambulance Coverage Requirements Revision. Additional Hardin County EMS ALS ambulance coverage requested for Cadet Summer Training (CST) 2023. Training will be conducted at the Fort Knox Night Infiltrations Course (NIC) from 2130-0200 on 14 July, 16 July, 24 July, 26 July, 3 August, and 5 August for CST 23 requiring onsite ALS ambulance coverage.

5. Fund Condition. This renewal is contingent upon the receipt of funding from Congress. If funds are not received, the Agreements Officer may suspend performance of the renewed period at no additional cost to the United States and reinstate performance once adequate funds are received. The Agreements Officer may also unilaterally terminate the Agreement without further liability to the United States if funds are not received.
