RESOLUTION NO. 2023-237**


BE IT RESOLVED, upon recommendation of Judge/Executive Keith L. Taul, to approve the following changes within the EMS Department:

1. The change of status of Madison Gibson from part-time EMT, Grade 9, Step 1, to 56 hour EMT, Grade 6, Step 1, at \$15.62 hourly, with a uniform allowance of \$500 per fiscal year, retroactive 19 November 2023.
2. The change of status of Rachel Cross (Purcell) from part-time Paramedic, Grade 14, Step 5, to 56 hour Paramedic, Grade 11, Step 5, at \$21.60 hourly, with a uniform allowance of \$500 per fiscal year, effective 17 December 2023.
3. The resignation of Nicholas Blakeman, part-time EMT, effective 03 December 2023.
4. The resignation of Christopher Bombagi, 56 hour Paramedic, effective 06 December 2023.
