

**HARDIN COUNTY FISCAL COURT
RESOLUTION NO. 2023-247**


BE IT RESOLVED, upon recommendation of Judge/Executive Keith L. Taul, to approve the following changes within the EMS Department:

1. The change of status of Racheal Goodlett from 40 hour EMT, Grade 10, Step 1, to 56 hour EMT, Grade 6, Step 1, at \$15.62 hourly, with a uniform allowance of \$500 per fiscal year, effective 31 December 2023.
2. The change of status of Madison Gibson from 56 hour EMT, Grade 6, Step 1, to part-time EMT, Grade 9, Step 1, at \$18.08 hourly, with a uniform allowance of \$250 per fiscal year, effective 17 December 2023.
3. The promotion of Lauren Jacobson from part-time EMT, Grade 9, Step 2, to part-time Paramedic, Grade 14, Step 2, at \$23.56 hourly, with a uniform allowance of \$250 per fiscal year, effective 17 December 2023.
4. The change of status of Lauren Jacobson from part-time Paramedic, Grade 14, Step 2, to 40 hour Paramedic, Grade 15, Step 2, at \$24.76 hourly, with a uniform allowance of \$500 per fiscal year, effective 31 December 2023.
5. The movement of Kirsten Sisk, 56 hour EMT, from Grade 6, Step EOI to Grade 6, Step 1, upon successful completion of her six-month introductory period, at \$15.62 hourly, effective 31 December 2023.
6. The change of status of Carter Hicks from part-time Paramedic, Grade 14, Step 4, to 56 hour Paramedic, Grade 11, Step 4, at \$21.18 hourly, with a uniform allowance of \$500 per fiscal year, effective 31 December 2023.
7. The resignation of Donald Highley, part-time Paramedic, effective 13 December 2023.
