

ORDINANCE NO. 341, SERIES 2024
ANNUAL STANDING ORDER TO PRE-APPROVE CERTAIN RECURRING EXPENSES
HARDIN COUNTY FISCAL COURT
Fiscal Year 2024-2025

Pursuant to KRS 68.275(3), "The Fiscal Court may adopt an order, to pre-approve the payments of monthly payroll and utility expenses. No other expenses shall be pre-approved pursuant to this subsection without the written consent of the State Local Finance Officer...". The Fiscal Court in accordance with state law hereby orders the recurring expenses for payroll, fringe benefits and/or utilities be paid when due.
