

**HARDIN COUNTY FISCAL COURT
RESOLUTION NO. 2024-191**

BE IT RESOLVED, upon recommendation of Judge/Executive Keith L. Taul, to approve the following changes within the EMS Department:

1. The promotion of Faith McManaway from 56 hour EMT, Grade 6, Step 5, to 56 hour EMT- Advanced, Grade 8, Step 5, at \$19.01 hourly, with a uniform allowance of \$500 per fiscal year, effective 22 September 2024.

7. The movement of Logan Savage, 56 hour Paramedic, from Grade 11, Step EOI to Grade 11, Step 1, upon successful completion of his six-month introductory period, at \$20.35 hourly, effective 22 September 2024.
8. The promotion of William Sawyer from 56 hour EMT, Grade 6, Step 2, to 56 hour EMT-Advanced, Grade 8, Step 2, at \$17.91 hourly, with a uniform allowance of \$500 per fiscal year, effective 22 September 2024.
9. The promotion of Ciara Brady from 56 hour EMT, Grade 6, Step 2, to 56 hour EMT-Advanced, Grade 8, Step 2, at \$17.91 hourly, with a uniform allowance of \$500 per fiscal year, effective 22 September 2024.
10. The promotion of Mason Freind from 56 hour EMT-Advanced, Grade 8, Step 3, to 56 hour Paramedic, Grade 11, Step 3, at \$21.18 hourly, with a uniform allowance of \$500 per fiscal year, effective 22 September 2024.
